What would Proposition 30 do?

Proposition 30 asks the richest Californians to pay their fair share to fund public education and vital public services. Prop 30 is the first step to restoring investment in California's future after years of slashing school programs. It brings back funding for teachers, school staff, libraries, and safe neighborhoods. It will prevent "trigger cuts" from further devastating our schools, higher education, and vital services.

Prop 30 raises \$6-9 Billion in new state revenue each year, 90% of which comes through a small increase in income tax on the wealthiest Californians for seven years: 1% on households making \$500,000 or more a year, 2% on households making \$600,000 a year, and 3% on households making \$1 million or more a year.

Prop 30 also increases the sales tax by just one-quarter of a cent for just

four years, which amounts to a penny more on a \$4.00 cheeseburger.

Prop 30 protects funding for K-14 education and early childhood, and frees billions in general fund dollars to restore cuts to higher education, healthcare, childcare, and other critical services. The accountability measures built into Prop 30 insures the money will go to education.

Vote YES on Prop 30.

What would Proposition 32 do?

Proposition 32 threatens everyone's workplace rights, wages and retirement—by prohibiting unions from participating in the political process. The measure's wealthy backers falsely claim it's about neutral "campaign finance reform," and "stopping special interests" from dominating politics. In fact, Prop 32 is deceitfully designed to silence workers' political voice, and give corporations even more power over politics and government than they already possess.

Prop 32 will stop all organizations from collecting funds for political action through payroll deductions. Sounds fair and even-handed, doesn't it? *But corporations don't use payroll deductions to collect funds for political action; they use corporate profits.* So unions will be prevented

from collecting political action money, and corporations won't. Corporations already outspend unions 15 -1 in politics. Prop 32 will make that ratio enormously worse.

Unions don't just advocate for their own members. By backing policies like increases in the minimum wage, and fair taxes on the rich to fund public education and social services, unions work on behalf of everyone in the 99%. Don't let billionaires control California's political process even more than they already do. ***Vote NO on Prop 32.***
